

BUNCKER® APPLICATION: UN-APPROVED AND CERTIFIED

Transport and storage <u>for all types</u> and <u>status of lithium batteries</u>: instabil suspicious including for recycling purposes), damaged, defect, prototype, refurbished, remanufatuctured and new lithium batteries

- UN-approved according to P911/LP906
- Heat insulated walls with non-combustible Altilium CP blanket and ventilation: controlling a thermal runaway
- Overpressure, pressure relief valve and circulation holes
- Outside of packaging remains lower than 100 degrees Celsius
- Filtering of dangerous HF gasses

PACKAGING INSTRUCTION

- The status of the lithium battery defines its classification. Due to worst case scenario testing according to P911/LP906, this pallet shipper can be used for lithium batteries in all stages and for multiple lithium battery shipments
 - o In case of damaged batteries (stable & instable) according to P908/LP904 & P911/LP911
 - In case of "prototype" batteries according to P910/LP905
 - In case of recycling (end of life) batteries according to P909
- When packing according to P908/LP904, P910/LP905 & P909 an inner packaging should be used per single battery
- When packing according to P911/LP906 no inner packaging are required
- Depending on the size of our UN approved packaging make sure you never exceed the tested maximum weight in kgs or the maximum electrical energy in kWh
